

FINISHED TEAK



CHARACTERISTICS

Our teak furniture is crafted using a wire brush with a pigment-based Natural Teak finish that will weather to a beautiful silvery-gray patina. As with any finish on outdoor furniture exposed to the elements, imperfections such as hairline cracks may develop. If left uncovered, the finish may flake off, exposing the unfinished wood. **Covering your teak furniture when not in use, as well as regular care and maintenance, will protect it from inclement weather and minimize aging. CLEANING

- Use a dry, clean cloth to dust furniture weekly and maintain luster. For spot cleaning, spray off any debris with a hose and brush off any dirt or debris with a soft- bristle brush because mold and mildew can thrive in environments with dirt and moisture. Dry with a soft cloth. To remove stains on finished teak, we recommend using a gentle scrub pad such as a 3M Scotch-Brite® Light Duty Scrubbing Pad 9030.
- For a more thorough cleaning, mix warm water with a mild dish soap, such as Dawn® or Method®, and clean with a soft-bristle brush. Do not use abrasive cleansers. Rinse with water and dry with a soft cloth. A power washing with a pressure of 1200-1400 PSI is also effective but should only be used by those individuals trained and skilled in the safe operation of power wash equipment. Furniture should be thoroughly cleaned periodically and always before storing.
- If furniture is in a saltwater environment, rinse weekly to remove all salt.
- If furniture is in a freezing environment, thoroughly clean and dry, then store in a dry place such as a garage or shed. Rain and snow will seep into small cracks and fill the wood with moisture and can lead to additional small cracks. If storage is not available, furniture should be covered with our custom-fit outdoor furniture covers.
- Avoid letting water stand on the surface of your furniture and cushions.
- When furniture is not in use for an extended period of time, protect it with our custom-fit outdoor covers. Before covering, furniture should be thoroughly cleaned and dried. Cushions should be removed and stored in a dry place if possible.

OUTDOOR LINE FABRICS

CHARACTERISTICS

The fabrics used in the MG+BW outdoor line are made of polypropylene to withstand the elements, resist mildew, stains and fading.

CLEANING

- Common household stains like tea, coffee, grease, chocolate or fruit juice are easily removed with a clean cloth and soapy water. Treat stains as soon as they occur. Remove any excess soiling material with a spoon or the blunt (not sharp!) edge of a dinner knife or, in the case of grease or liquid stains, with absorbent paper.
- Mix water with a neutral detergent. Wipe the stain with a clean cotton cloth damped with soapy water. For persistent stains, moisten the fabric with soapy water and rub gently. Repeat the treatment if necessary. When the stain disappears, rub dry with a clean cotton cloth.
- Let dry at room temperature. Do not sit or place anything on the furniture until the cover is completely dry.

WASHING

- Wash the sofa covers inside out and with the zipper or velcro closed.
- Wash at a maximum of 80° F with a washing machine program for delicate garments.
- Use a neutral detergent and no softener.
- Do not wash with other textiles or garments.
- Do not load the washing machine excessively.

DRYING

- After machine washing and with the cover still moist, stretch in both directions.
- Lay flat and let air dry.
- Avoid direct exposure to sunlight.
- Assure that the cover is completely dry before resuming use.

CUSHIONS

CHARACTERISTICS

Standard cushions are constructed from “quick-dry” foam and covered with an anti-microbial, water-resistant fabric. Although our upholstery is mildew resistant, mold and mildew can thrive in environments with dirt and moisture. To deter mold and mildew, always remove wet cushions from furniture frames and perform monthly cleaning and maintenance.

CLEANING

- Use a dry, soft-bristle brush to dust fabric weekly and remove dirt before it becomes embedded.
- For spot cleaning, use a mild cleaner such as Simple Green® or OxiClean™ with warm water and a soft-bristle brush. Rinse thoroughly. Flip cushions on their sides with the zipper facing down and unzipped to ensure that all water drains.
- For a more thorough cleaning, power washing with a pressure of 1200-1400 PSI can be highly effective, however pressure greater than 1200-1400 PSI may damage the fibers. Hold the power washer approximately 30” away from the pillow to wash away mold and mildew. Repeat as necessary to achieve desired results. Flip cushions on their sides with the zipper facing down and unzipped to ensure that all water drains. Note: Power washing should only be used by those trained and skilled in the safe operation of power wash equipment.
- Avoid letting water stand on the surface of your furniture and cushions. When cushions are not in use for an extended period of time, they should be removed and stored in a dry place if possible. For standard cushions left in heavy rain, simply unzip and down to help water drain. Allow to air-dry.

We sincerely believe that this piece of furniture will provide you with years of pleasure. To reinforce this belief, Mitchell Gold + Bob Williams warrants to you, the original purchaser, the following Limited Warranty coverage:

Mitchell Gold + Bob Williams warrants its outdoor furniture products to be free from defects in material and workmanship under normal use and service for a period of three (3) years from the date of purchase for wood and aluminum frames and one (1) year from date of purchase for against tearing and abnormal discoloration or fading of fabrics on cushions, cushion foam, and any woven product coverings.

Furniture in which such defects occur will be repaired or replaced at Mitchell Gold + Bob Williams' option. If repair or replacement is not practical, at the option of Mitchell Gold + Bob Williams, alternate financial remuneration may be paid or the product may be substituted. This remedy is exclusive and Mitchell Gold + Bob Williams does not authorize any person to create for it any other obligation or liability in connection with this furniture.

Customer assumes all freight charges to/from Mitchell Gold + Bob Williams after the first year.

This Limited Warranty applies under conditions of normal residential usage only and does not apply to defects or damage resulting from (a) negligence, abuse or misuse; (b) inadequate or improper maintenance, cleaning or care; (c) exposure to chemicals and/or liquids; (d) accidents; (e) spills and stains; (f) flattening or compression of cushions and pads; or (g) any use for which the product was not designed. Transportation or delivery damage is excluded, and will have to be handled with the carrier. (Sorry!)

Teak furniture is made of naturally variable raw materials. Differences in grain character and color among wood species are naturally occurring variations and are not within the control of the manufacturer nor considered defects under this warranty. Natural color or patina changes over time and exposure to extreme temperature changes may cause color changes and/or surface damage and are not covered by this warranty.

This Limited Warranty applies only when you purchase the Mitchell Gold + Bob Williams furniture from a Mitchell Gold + Bob Williams Authorized Dealer for your own use and terminates in the event of resale.

This Limited Warranty does not cover (a) floor samples or products designated "AS IS" at the time of purchase (b) differences between floor samples or differences from printed illustrations, video or internet displays.

This Limited Warranty gives you specific legal rights. You may have other rights which vary from state to state. TO THE EXTENT PERMITTED BY LAW, ALL IMPLIED WARRANTIES, INCLUDING ANY WARRANTY OF MERCHANTABILITY OR WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE, ARE HEREBY DISCLAIMED, AND MITCHELL GOLD + BOB WILLIAMS SHALL NOT BE LIABLE FOR ANY INDIRECT, CONSEQUENTIAL OR PUNITIVE DAMAGES.
